16 fail to make, sign, or verify a return, or supply any information required, to wit: Oregon
17 Individual Income Tax Return for the year 2007. Said acts or omissions constituting a crime
18 committed against the Oregon Department of Revenue located in Marion County, Oregon.



2 crime committed against the Oregon Department of Revenue located in Marion County, Oregon.


